Questionable works



In the final segment of KRG's unprecedented interview, Ritchie "Stardreamer" Sinclair—the apprentice who was actually present with Norval Morrisseau during the late 1970s—speaks directly to the issue of questionable Morrisseau paintings. He doesn't see himself being the one to say what is real or what is not. Ritchie knows the artworks will show themselves and that Morrisseau's own works will rise to the top. He knows Norval's skills are not easily reproduced and others cannot repeat Morrisseau's success in a painting. Simply put, they cannot duplicate his genius. Sinclair proposes that we reinforce the authentic Morrisseaus that we know are unequivocally his due to their rock-solid provenance. Art history shows that the passage of time will eliminate the garbage, though Sinclair is saddened that innocent people will get caught-up in the meantime.

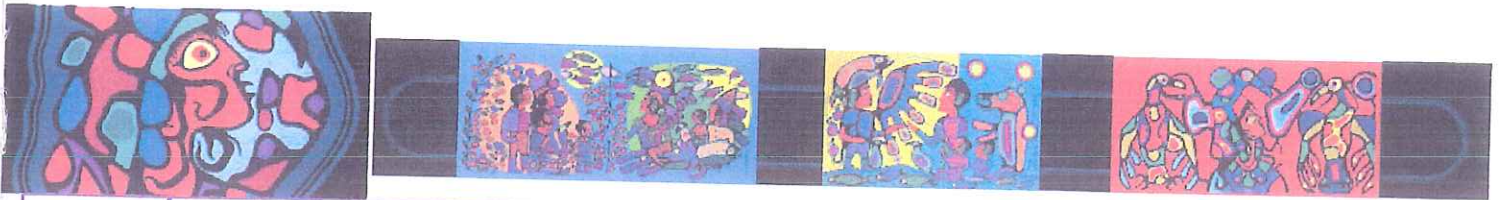
